Wilson College Scholarship Opportunities

MERIT SCHOLARSHIPS (First-Year and Transfer Applicants)

- First-year students must be enrolled in a full college-prep high school curriculum that includes a minimum of 15 academic units.
- Transfer students must have a minimum of 9 transferrable courses; with less than 9, a combination of high school record and college record will determine eligibility.
- Scholarships are for students who are enrolled full-time.

Merit Scholarships are awarded at the point of admission to Wilson College. Scholarships are renewable with the maintenance of a 2.75 cumulative GPA.

Award	Amount	Eligibility Requirements	Application Process
Presidential Scholarship	50% of Tuition	Cumulative GPA of 3.75 or higher. First-year applicants must rank in top 15% of class.	Automatically awarded to qualified full-time students.
Dean's Scholarship	35% of Tuition	Cumulative GPA of 3.4 to 3.74. First-year applicants must rank in top 25% of class.	Automatically awarded to qualified full-time students.
Faculty Scholarship	25% of Tuition	Cumulative GPA of 3.0 to 3.39. First-year applicants must rank in top 50% of class.	Automatically awarded to qualified full-time students.

COMPETITIVE SCHOLARSHIPS

SEBCLAR Scholarship "Scholarships to Enhance Biology and Chemistry Learning and Research"	Up to \$10,000	Awarded to students majoring in Biology or Chemistry. Funded by the National Science Foundation. Applicants must demonstrate prior academic achievement in science and mathematics. Must be U.S. citizens, permanent residents or refugees admitted to the College with financial need based on the FAFSA.	Application must be submitted. Deadline: March 1
Curran Scholarship	Range from \$4,000 for freshman to \$7,000 for upperclass students	Awarded to students with a proven history of community, school and/or religious service as well as academic achievement and leadership qualities. Recipients are required to complete 260 hours of community service during the year.	Application form, Two recommendation forms and essay are to be submitted for consideration. Deadline: March 1

AFFILIATION SCHOLARSHIPS

Presbyterian Student Scholarship	\$1,000	Active members of the Presbyterian Church (USA) who are enrolled full-time at Wilson College are eligible.	Automatically awarded to qualified full-time students.
Girl Scout Gold Award	\$1,000	Gold Award recipients with at least a 3.0 high school GPA.	Automatically awarded to qualified full-time students.
Pony Club	\$1,000	Pony Clubbers with a rating of C-3 or higher who have a high school GPA of 3.0 or better.	Automatically awarded to qualified full-time students.
PHI THETA KAPPA Scholarship	\$1,000	Awarded to transfer students who are members of Phi Theta Kappa. Recognizes both academic achievement and community service.	This award may be combined with the Transfer Merit Scholarship.

* The criteria listed determines eligibility only and does not guarantee receipt of the scholarship.
NOTE: Application for admission must be complete by the scholarship deadline in order to be considered for scholarship.
